- 3. The GRC/SGRC shall send its report with recommendations, if any, to do concerned Council and copy thereof to the aggrieved Student, Faculty or Staff member, within a period of 15 days from the date of receipt of the complaint.
- 4. In case the student or faculty/ staff is not satisfied with the decision of SGRC/GRC they may appeal to the concerned council or board for their redressal of their grievances.
